1. Introduction

The European Commission (hereafter 'the Commission') is committed to protect your personal data and to respect your privacy. The Commission collects and further processes personal data pursuant to Regulation (EU) 2018/1725 of the European Parliament and of the Council of 23 October 2018 on the protection of natural persons with regard to the processing of personal data by the Union institutions, bodies, offices and agencies and on the free movement of such data (repealing Regulation (EC) No 45/2001).

This privacy statement explains the reason for the processing of your personal data, the way we collect, handle and ensure protection of all personal data provided, how that information is used and what rights you have in relation to your personal data. It also specifies the contact details of the responsible Data Controller with whom you may exercise your rights, the Data Protection Officer and the European Data Protection Supervisor.

The information in relation to processing operation Contact lists & network partners databases at the JRC undertaken by JRC.E.5 (*the responsible Unit*) is presented below.

2. Why and how do we process your personal data?

<u>Purpose of the processing operation</u>: JRC.E.5 collects and uses your personal information to send addressees information (text, newsletters, documents, publications, video material etc.) on JRC activities, events and scientific results.

This processing of personal data allows the Joint Research Centre (JRC) to draw up and manage lists of individuals who, either in their personal capacity or on behalf of an organisation, are interested in JRC's work.

Your personal data will <u>not</u> be used for an automated decision-making including profiling.

3. On what legal ground(s) do we process your personal data

We process your personal data, because you have given consent to the processing of your personal data for specific purposes point (d) of Article 5(1) of Regulation (EU) 2018/1725.

We do not process **special categories of personal data**, therefore Article 10 of Regulation (EU) 2018/1725 does not apply

4. Which personal data do we collect and further process?

In order to carry out this processing operation JRC.E.5 collects the following categories of personal data:

- title, gender, name/surname, company/organisation name, position, private and/or professional email address, private and/or professional postal address, office/private phone/fax, website; - fields of interest.

The provision of personal data is not mandatory.

5. How long do we keep your personal data?

JRC.E.5 only keeps your personal data for the time necessary to fulfil the purpose of collection or further processing, namely as long as JRC continues to work in support of research and innovation.

6. How do we protect and safeguard your personal data?

All personal data in electronic format (e-mails, documents, databases, uploaded batches of data, etc.) are stored on the servers of the European Commission. All processing operations are carried out pursuant to the <u>Commission Decision (EU, EURATOM) 2017/46</u> of 10 January 2017 on the security of communication and information systems in the European Commission.

In order to protect your personal data, the Commission has put in place a number of technical and organisational measures in place. Technical measures include appropriate actions to address online security, risk of data loss, alteration of data or unauthorised access, taking into consideration the risk presented by the processing and the nature of the personal data being processed. Organisational measures include restricting access to the personal data solely to authorised persons with a legitimate need to know for the purposes of this processing operation.

7. Who has access to your personal data and to whom is it disclosed?

Access to your personal data is provided to the Commission staff responsible for carrying out this processing operation and to authorised staff according to the "need to know" principle. Such staff abide by statutory, and when required, additional confidentiality agreements.

Access to personal data is allowed to authorised officials and other staff of the JRC. Data may be communicated to an external entity assisting the Commission in fulfilling the objective for which the data is managed.

8. What are your rights and how can you exercise them?

You have specific rights as a 'data subject' under Chapter III (Articles 14-25) of Regulation (EU) 2018/1725, in particular the right to access, rectify or erase your personal data and the right to restrict the processing of your personal data. Where applicable, you also have the right to object to the processing or the right to data portability.

You have consented to provide your personal data to JRC.E.5 for the present processing operation. You can withdraw your consent at any time by notifying the Data Controller. The withdrawal will not affect the lawfulness of the processing carried out before you have withdrawn the consent.

You can exercise your rights by contacting the Data Controller, or in case of conflict the Data Protection Officer. If necessary, you can also address the European Data Protection Supervisor. Their contact information is given under Heading 9 below.

Where you wish to exercise your rights in the context of one or several specific processing operations, please provide their description (i.e. their Record reference(s) as specified under Heading 10 below) in your request.
